When you're a GSR

When you're a GSR, you are linking your home group with the whole of AA. Back in 1953, when the "group contact" was suggested as a new type of trusted servant, the job was seen simply as a good means of exchanging up-to-date between individual groups and "Headquarters" (now the General Service Office). That's still an important side of your work. But now, as general service representative, you have an even bigger responsibility: You transmit ideas and opinions, as well as facts: through you, the group conscience becomes a part of "the collective conscience of our whole Fellowship," as expressed in the General Service Conference. everything else in AA, it works through a series of simple steps. For a complete picture in detail, read The AA Service Manual. At district meetings you join with GRS's from other groups. Perhaps you've already worked with an intergroup or central office, where groups band together to help alcoholics just in your locality. But your general service district is the second link in an entirely different chain, which extends much farther. Your district is one part of a general service area. With your fellow GSR's, you elect a district committee member, and all the DCM's make up the area committee. Now, do you just sit back and let your DCM take it from there? No! GSR's stay very much in action in each of the 93 areas in the U.S. and Canada. You attend area assemblies four times a year (in most areas). At the electoral assembly (held every two years), along with the other GSR's and the DCM's from the whole area, you elect committee officers — and your area's Conference Delegate. (Editors Note: Our current Conference (Area) Delegate just happens to be a current member of Alcoholics Anonymous right here in Tampa!!!) Just as you rely on your group for help in your personal recovery, so the AA group of Canada and the U.S. rely on the General Service Conference in maintaining the unity and strength of our Fellowship—our obligation to all the alcoholics of today and tomorrow. It's up to you to keep two-way communication going between your group and the Conference. Via your DCM and your delegate, you can

DISTRICT 2 GENERAL SERVICE

AA does not just consist of AA groups. There are different classifications of AA meetings, which are referred to in Tradition 9: they are Service Committees and Service Boards. Service Committees and Service Boards do the jobs that the groups cannot do for themselves and that require cooperation between them. Let's each of us just think for a moment about how we found our first AA meeting: perhaps we saw a pamphlet in a doctor's waiting room and contacted the AA answering service, which in turn directed us to a meeting; or perhaps we saw details of a group on the Internet. Once we are in AA we find meetings by using the AA meeting schedule. All of these services are provided by the joint efforts of AA members through various Service Committees. Some Service Committees, such as Intergroup or Central Office, cover local areas or Districts. District 2 is our District and it covers Hillsborough and East Pasco County. Central Office is usually our first contact with the service structure. For those of you who don't know or have forgotten, Central Office provides a number of services acting as a clearing house for the convenience of members and groups. They also provide phone service for twelfth step calls and other inquires, help with the coordination of group activities and keeping track of meeting times and changes and print the schedules, edit and print a monthly newsletter and in addition sell all Alcoholics Anonymous General Service Conference Literature and some other materials. **But** what about District 2 General Service? What do they do? As you can see from the article about GSR's they act as a liaison between the Groups and the rest of the A.A. Service structure. They do the jobs that the groups cannot do for themselves. Within the District 2 service structure they have several different committees that provide important functions for the groups, allowing the groups to be freed up to "carry the message" to the still suffering alcoholic, in and out of our rooms. You have the **Grapevine Committee** that gets the word out about our "meeting in print" magazine. The Grapevine Representatives encourage new subscriptions and are usually alternate GSR''s. Then there's the Archives Committee who gathers, displays records and preserves the historical information about A.A. in our Area. It's important to know where we can from in order to know and appreciate what our founders had to go through so that you and I can enjoy the freedoms in A.A. that we experience today. Then there is the Public Information/ Cooperation with the **Professional Community Committee.** They provide information about A.A. to the media, professional groups, schools, physicians, lawyers, judges, the police and the clergy. experience among area delegates and the other Conference members. Your DCM may want to present your delegates report at a special group meeting. The DCM receives a copy of the Final Conference Report, a full account of proceedings. Copies of the **Report** are available to groups upon request. As GSR, you are "group contact" in the original sense, too. Upon your election, your name and address are sent (by you or your group secretary) to the secretary of your area committee, and your district or area registrar and to GSO. (Be sure to include, as well, the name of the GSR you are replacing, so the records won't be confused.) You will be listed as contact for your group in the next printing of the appropriate AA Directory. In return, GSO sends you the GSR Kit (see the section below for some of its contents), and the bimonthly bulletin Box 4-5-9. You use these—and share them with the other members of your group. Are some pamphlets marked "new" on the Literature Order Form? You check the literature rack to make sure your group is offering all the sobriety tools available. Does Box 4-5-9 carry news of a future International Convention? You spread the happy word. Because you've made a special point of studying the information listed below, you can help when your group faces a problem involving one of the Traditions. You don't have to know all the answers—no one member possibly could—but you learn where to look for good suggestions. drawn from broad AA experience. Thinking of Tradition Seven particularly, you work with the group treasurer to remind your group of its part in keeping all of AA self-supporting. You explain the importance financial support of your intergroup/central office, GSO, district and area committee, and the Birthday Plan for individual contributions. Since you're in touch with AA throughout your area, you can bring to your group the news of upcoming local conventions. As GSR, you share with your fellow members the joy of widening AA horizons. **Information you'll need** on the **general service structure**: The AA Service Manual/Twelve Concepts for World Service, "Inside AA.", and "Circles of Love and Service" all in the GSR Kit in addition, the Final Conference Report. ``AATraditions: Tradition-How Developed" (kit); also Twelve Steps and Twelve Traditions, AA Come of Age, and "The Twelve Traditions Illustrated." When your group elects a GSR you remember as the cover of this leaflet says, that "GSR may be the most important job in AA." The GSR's of the U.S. and Canada are the very foundation of our general service structure. Through your GSR, you can make your group's voice heard at district meetings, at area assemblies, and eventually at the General Service Conference. Through your GSR, your group is strengthened by the shared experience of other AA members. The two-vear terms of an area's GSR's

coincide with those of it's DCM's and Conference delegate. So a group usually elects it's GSR before the assembly meeting at which the delegate is elected. September is a good month, since that gives the new GSR time to study the responsibilities of the job before taking office—most often on January 1, along with the new DCM's and the new delegate. An informed group enjoys a special election meeting, where a member with a solid background in service work explains the function of the GSR, and a GSO filmstrip may be shown. **Procedures** for electing a GSR are the same as for any other group officer. There should be time for nominations from the floor, then for written ballots. A plurality is usually enough for an election. Prompt notification about your choice of GSR is essential. If your district or area committee and GSO do not have your new GSR's name and address, communication breaks down. At the same election meeting, it is important also to elect an alternate GSR (by the same voting procedure). The two will work together closely, so that the alternate can be a knowledgeable replacement if the GSR is unable to attend a district or area meeting. What happens if your groups GSR is **elected committee member** for your district? Then the alternate automactically becomes your GSR-an extra reason for care in filling both offices. The makings of a good GSR: Two or three years sobriety is generally the required minimum. Active membership in a home groupyours—is also important, and your GSR should hold no other offices in any group. Prior service AA**experience** provides a long head start for a GSR's success. Consider former group officers and members who have shouldered responsibility at your intergroup or central office or on special committees. Does your group include people who already have a keen interest in the Twelve Traditions and the service structure? If so, you're in luck! Look for the same character qualities that mark a good trusted servant of any sort (and a good AA): patience, understanding, and a determination "to place principles personalities." Most future Conference delegates will come from the ranks of todays GSR's so your choice now can help to insure good representation for your whole area in years to come and continuing vitality for our General Service Conference—the heart of our co-founders Third Legacy to all of AA.

He noted that we were \$155.97 to the good this month over our budget. All line items and expenses look acceptable. Stan asked if all ticket sales from the Dinner had come in and how the Softball Tournament had turned out. The Dinner netted over \$2600.00 dollars from pre and post ticket sales, expenses were a little over \$1100.00 so we actually netted a little over \$1400.00. In Old Business Tim was asked to leave the room while the Board discussed his increase in Health Insurance and his annual Review. After 10 or 15 minutes Tim was called back in and informed that the Board would continue to pay his Health Insurance and both he and the part-time helper Keith B. had been granted a slight increase in their wages. Tim thanked everyone for both he and Keith. Tim gave his Central Office District 2 Liaison report to the Board noting that several positions are open for DCM's and ACM's and also just like us, the District is experiencing a financial crunch with contributions being down. Tim also noted that the District is still looking for a new place to hold their monthly meeting. Discussion followed about how to informed the AA community of the need for contributions. The Council meeting opened up in the usual matter and we welcome two new COR's Trish from a new group the Lunch Bunch and Jodie from the AA 101 Group. Wendy read the February minutes. There was no discussion. A motion to accept the minutes were made, it was seconded and approved. Stan went into his Treasurer's report noting that we had \$7731.21 in contributions in February. (Ed. Note: \$2439.70 was from the Dinner, \$500.00 from the Softball Tournament and \$750.00 was from the Old School Group's Anniversary Dinner—without this extra income that month—contributions would have only been \$4041.51. Then subtract the \$1100.00 and change for expenses from the Dinner and the \$335.00 paid to the ASA and the City of Tampa and Insurance to hold the Softball Tournament—it starts to paint a different picture of how well we ready did for that month.) The Old School Group and Bill S. their COR was given a round of applause for their contribution from their Dinner. We finished the year-to date with \$958.05 to the good so far.

plenty of people out there that have no idea what A.A. is or isn't. You can even see that at some of our meetings!!! We have the **Institutions Committee** (see page 2) who take meetings into rehad centers and the jails and prisons. Then there is the Special Needs Committee who provide assistance or access to AA meetings for those unable to manage. They take meetings to homebound and hospital bound members of A.A. Then we have the Literature Committee who keeps us and you informed of the different changes to the wording and format our books and pamphlets. If we didn't know what was being done, our books and other literature could be changed radically and lose the essence of the A.A. program and we wouldn't even know it until it was too late. Along with these vital committees we have other Committees such as the Finance Committee, the Special Events Committee, the Current Practices Committee and the Central Office Liaison.
