Report From an Unemployed Monkey

I'm a Monkey. You can call me Moe. Until a short time ago I had a steady job, riding on the back of an alcoholic named B. Now I'm out of work, and I'm sad as hell. Let me tell you about it. I first climbed up on B.'s back about three years ago, just after he got sober. A lot of drunks have a monkey with them throughout their drinking careers, but B. was different. He was a high-bottom who really didn't suffer that much while he was on the booze. He drank just enough to avoid life and to make himself think he was fairly happy. But as the years went by he got bothered more and more by the feeling that something was missing. So one day he stopped drinking. His wife and kids were still with him at the time. He had a home in the suburbs, a steady job, friends, good health. When B. quit booze and joined AA, he hoped to find peace. But it didn't come. Instead, he got me. Man, was I happy! And B. ever sore! I got my first good hold on B. when he began to realize that he had a lousy marriage. For nine long years those three martinis each night had kept him from seeing that he was a third-class s.o.b. (which, to his wife, was worse than being married to a first-class s.o.b. whom she would have walked out on early in the game). In his early AA meetings, B. listened to tales of how sobriety had saved so many marriages. And because B.'s was falling apart, he got mad as hell—at God, AA, sobriety, the whole world. A year after B. joined AA, his wife took the kids and went back to her home town. Even then, B. refused to return to alcohol. He was a tough nut. But I still got my licks in. A monkey worth his salt doesn't need booze to help him do his work. He can raise hell even with a dry alcoholic. And that's just what I did. First I gave him so much rage and resentment that he developed colitis. You should have seen him squirm. Really gratifying! Then, not long after his wife left, he met this terrific AA gal. They really liked each other. But I kept on his back, so that about once a week B. would fly into a tantrum, pick a stupid fight with the girl, and almost wreck the whole business. He stayed miserable and confused. Beautiful! I solidified my position by keeping him so proud and aloof that, even into his second year of AA, he didn't really commit himself to the organization. He'd attend two or three meetings a week and go through the motions, but he wouldn't unbend and really give in to AA. He was still dry, but he wasn't serene. He was neither drunk nor sober, and he knew it. I'd keep telling him that he's be better off drinking, but he wouldn't buy that argument. A real fence-sitter. We'd perch up there together, and I had every confidence that sooner or later I'd topple him into the drunk-bin. My hopes really began to rise after he was two years sober. That's when I broke out my really big guns: boredom, lack of faith, impatience, and an unwillingness to believe that sobriety ultimately pays off. 'Face it, B.!" I'd tell him. "Here you are dry for two whole years, and what's it got you? Your wife's divorcing you, you're unhappy at work, your AA girlfriend is ready to quit you in disgust, and there' no end in sight. You've gone to a psychiatrist, a marathon, hundreds of AA meetings, and you've had dozens of AA friends

CHARLIE

Charlie wa out on parole. He came to our meeting on court order, was given a Big Book, and was encouraged to read it. The first few weeks his head was bowed in sorrow—and probably shame. Charlie could barely read, and getting through page after page of the Big Book was an almost impossible task for him. But as he read, and continued to show up at meetings, his head lifted and his eyes began to shine. We even saw a grin begin to appear—a toothless one, no doubt the result of countless barroom brawl. Most meetings Charlie would say, "I'm Charlie, I'm an alcoholic, and I pass." And then we old-timers would share our comments, our tidbits of wisdom, our Big Book quotes. One meeting, a few months later, we had chosen "serenity" as our topic. Delving into a deep discussion on peace of mind, we were brought back to earth by a now-sober Charlie who grinned and grinned again. He said, "I'm Charlie, I'm an alcoholic," and then he added this simple phrase, :Thanks to this program, my life is going all right, today!" And, you know, in all our sobriety, with all of our attemts at great wisdom, Charlie had stated what we all wanted most! We knew it by the recovery in him-by his uplifted head, his toothless smile, and by that statement. He had found that following a few simple suggestions—picking up a spiritual kit of tools—and leaving the results to a power greater than ourselves gives us all a life that is going all right, today.

Maybe if you really get hurt this time, you'll finally be able to get the program. You just need to suffer a little bit more, and women inmates in this program have earned the privilege and hit a lower bottom. How about it, B.? Just one more drunk, to work at a job outside the prison. Many will soon be paroled. and I promise you I'll never bother you again." I kept it up, and about the time he reached his thirty-month anniversary, I thought I had him. For short periods I'd let him think he was rid of me. Sometimes this work is frustrating. I am the only active Then, just when he felt steady, I'd hit him: wham! I'd climb up Citizen Volunteer at this prison. SELF-SUPPORT-February, 2017

© Today in February of 2017 we have 225 Groups with 559 meetings a week. Contributions in February totaled \$7,329.73. That accounts for what 23 Groups out of 225 Groups in our area have contributed in February. This also takes into account the \$40.00 from 1 member who contributed to the Birthday Club and \$833.12 from the Soberilla 12 Step Workshop. Also included in this amount is \$3,961.44 collected from the Tri-County Central Office Anniversary Dinner. Our total income for February was \$13,934.26. Our Cost of Goods Sold was \$4,865.46. Subtracting the Cost of Goods Sold from our February income left us with a Gross Profit of \$9,068.46. Our Total Expenses for February were \$8,587.47. Subtracting our Expenses from our Gross Profit gave us a Net Income of plus+\$480.99 for the month of February. To put things in a more realistic perspective, if it wasn't for the \$40.00 from 1 member who had contributed to the Birthday Club, the \$833.12 collected from the Soberilla 12 Step Workshop, and the \$3,961.44 collected from the Tri-County Central Office Anniversary Dinner, we would have been \$2,024.29 in the red for the month. That's why your contributions matter. No matter how good we might be doing from one month to another, it takes your consistent contributions to keep us operating on a steady level. As our AA membership continues to grow in the Tampa Bay area, the demand for more and more material and services continue to expand and we continue to try and strive to keep up with the demand. That is only possible with your continued support. Thank you for all of your support !!!


