WHAT IS AN ENABLER? When I was drinking I depended on others gullibility and basic

When I first arrived in AA, some years ago, I took everything I heard completely literally. And I heard a lot of "truths"—some of them frequently repeated. Taken with total literalness, they had me very confused. For example: At one meeting, I discussed my teenage son who was creating the usual teenage problems for me and my wife. I was told, "Expect nothing." Everyone nodded, so I knew that must be good advice. But it when against what good sense I had left. Why not expect certain things of your son, your perhaps I should say threw me—into AA. And I have been pretty wife, your friend in AA? I came to realize there is nothing wrong at all in such expectations; the mistake drunks like me made and mike is demanding that people live up to our picture of what's right or wrong, then falling apart when they don't—and maybe even reaching for a drink when the frustration becomes too much. I still expect good things and good behavior from people to the drunks who haven't got here yet, as well as those who are around me; I certainly don't insist on it. When they fail to meet already here. Should I let it happen? Example: "All addictions my expectations, I look at those expectations to see if they were are the same," intones the leader of a closed AA meeting. reasonable. Whether they were or not, I try not to lose any sleep over it. And I certainly don't think about picking up another first drink. "Don't worry about tomorrow." I heard that one when I talked about leaving a longtime job and starting a whole new life that would be much more exciting and a lot more precarious. Again, everyone nodded. Again, it took me some time to realize that just about everyone is concerned, to one degree or another, about tomorrow. If you weren't, you wouldn't put money aside for the rent. The danger drunks like me lies in allowing tomorrow to obsess me, to be the focal point of my thoughts, so I fail to enjoy today. If I can keep tomorrow in proper perspective. making the now the important part of my program without neglecting the future, I am practicing the program as I understand it. "Don't make judgments." The first time I heard that, it sounded very good, momentarily. But who doesn't make up? Answer: I have no answer. You tell me. Another example: judgments? You look at a sunset and say it's beautiful. You hear a speaker and say she really was terrific. Those are judgments. Everyone makes them, many of them, each day. Again, the danger for me is insisting that only my judgments are valid. And the healthy road lies in continuing to make judgments, but always giving the other person the right to be wrong, without insisting that my will be done. Another impressive AA observation was "Don't let resentment or fear affect your thinking." How can we keep it from being affected? "We are not saints." I learned I cannot prevent fear or anger from entering my thoughts occasionally; what I can do is step back, know the danger they represent, examine why I felt that way, and put them out of my head and life by doing something constructive, like making a Twelfth Step phone call or visit. But as long as I am human, I expect I'll experience some fear, some resentment. The big difference is that now I think I know how to recognize and deal with these feelings with some degree of sanity. I heard, too, "Don't be concerned about results—look only at the effort." Sounds good. But for me, I had to think about the Go to page 3

Results of my actions. Such forethought was

sympathy to get me out of scrapes, indulge my temper tantrums, and in general enable me to conduct a bizarre, insane, drunken life. I thought it would go on forever. But in time, my enablers revolted. They ceased their indulgence and psychologically, if not actually, shook me by the shoulders. Today, I thank God they did. Thirty-one years ago, my former enablers ushered me—or happy here ever since. End of story? Yes, except for one small thing. I find that now I myself may be an enabler of bizarre, injurious behavior. I could be permitting, by my silence at certain AA meetings, the wholesale cheapening and trivializing of the program of Alcoholics Anonymous. That could cause real harm "There's no need to differentiate among ourselves. It doesn't matter to what substance we are addicted. All we need to do is learn more about addictions and through this knowledge free ourselves from all addictions—not only alcohol, but nicotine, caffeine, salt, sugar, meat and all animal products, as well as sex and bicycle riding. That's what AA is for." Question: Is there an inner wisdom in the group that will by itself cause us to ignore this malarkey as we should? What needs to be done to reassure newcomers that they are in the right place for an alcohol problem—that we are truly not a cult with a multipurpose agenda? That our essential purpose is to carry our message to the alcoholic who still suffers? Do I sit there quietly or do I stand and say my piece about the singleness of purpose of AA? Do I become an enabler if I don't speak up? Or a bad guy if I do speak An AA meeting becomes more "sales and service" than love and service. The constant din of requests for more money causes Seventh Tradition contributions to go way down instead of up, as many AAs, normally responsive, turn off. Some of the leadership, feeling its power threatened, becomes rough and arrogant, attacking personalities and blaming others for its failures. It even refuses, after numerous petitions from members, to properly account for funds it handles. Bizarre? Hardly believable? Maybe, but it's true. Question: By silence, indifference, and perhaps a kind of spiritual fatigue, do I, along with a good number of others, allow myself to become an enabler? If I take the easiest way and say nothing, what about my conscience? What kind of example do I set for those who trust me as a sponsor? Answer: Up to now I have felt I should reject the role of enabler. But when I ask my sponsor or my friends or others in the Fellowship what to do, the results are mixed. Some urge silence and acceptance, others suggest openness and action. So I'm asking you. Which is the right way? To enable—or not?

The Most Important Job in AA

When I was new in AA, I went to the meetings and sat in the chairs and drank the coffee and tried to make sense out of what I heard. After a while, I picked up the pamphlets and read them. Later, I bought a Big Book and began to read that. I stayed sober, and my family life and my business affairs improved, and I continued to sit in the chairs and drink the coffee. But, like a small, protected child, never once did I wonder why the chairs were always ready when I came into the meeting hall. Then one night there was no coffee. When the people came in and saw no big, shiny urn in its usual place, they stood dazed. In petulant tones, they asked each other, "Why haven't they made the coffee?" I looked around for the mysterious "they." Finally, one of the regular members rushed in from the parking lot, ran to the kitchen, took the urn down from the shelf, and began filling it with water. "They" had arrived. "They" turned out to be just one person—a quiet little man who had faithfully made the coffee each meeting night for more than a year. On this particular evening, his car had broken down on his way to the hall. On that night, I may have crossed the invisible line that separates the indifferent from those who are aware that well-placed chairs and tables, and coffee and cookies and literature, just don't happen. I did not immediately transform myself into an active, useful member of AA as the result of that one lesson. But I began to appreciate a little more the efforts of the group secretary, the chairman, the treasurer, and the members of the steering committee. Fairlyearly in my sobriety, my group chose me at different times to be secretary, program chairman, and a member of the steering committee. Later in 1967, my group elected me their general service representative (GSR). It was then that my education about AA really began, and with it a deepening love of the program and appreciation of its power. As GSR, I was my group's link with AA as a whole, the means of conveying my groyp's views and needs to the General Service Conference. Through me, if I acted in a responsible manner, my group in turn learned how other groups were solving common problems, not only in my area, but all over the United States and Canada. Among the service offices I have held are district committee member, delegate, and several functions in many service conferences in the Pacific Coast Region in which AAs from seven Western states participate. This does not make me an expert nor qualify me to speak for the Fellowship. But just as we learn about our recovery program from AAs who have experienced sobriety, so I learned about the problems of communication and service from my fellow GSR's, delegates, and other elected AA workers. I would like, through the Grapevine, to share with you some of my thoughts based on these experiences and observations. The most important job in AA, in my opinion, is that of the GSR. This may seem strange, since there are thousands of GSRs and a rapidly decreasing number of other offices as one scans the structure chart from GSR on to district committee member, delegate, and trustee. There are, for instance, ninety-one Conference delegates (from area of the United Staes and Canada) and fourteen alcoholic trustees. Why, then, don't I consider delegates or trustees more important? The importance of the GSR to our Fellowship was beautifully summed up by a trustee from Canada at a General

Service Conference a few years ago: "If we want

better trustees, we need better delegates. If we want

inevitable and human. Here again, it was a matter of proportion. If I was so zeroed-in on results that every action was guided by that perspective, I could miss a great deal. My concentration—without disregarding possible results—is always on the action, on the effort. If that is right and wholehearted, I know the results are likely to be good and positive. But results still do enter into my thinking. Finally, there's the one we all know: "Don't analyze. Utilize." As if there was a contradiction between the two! I learned it was possible for me to over examine and overanalyze aspects of this program and become mired in complete bewilderment bewilderment dangerous for me as an alcoholic. It was necessary for me, a complicated thinker from way back, to 'keep it simple." That did not mean I had to give up my right to think. But always, always uppermost in my mind was the need to put the program as I understood it into action. That is the main thrust of my AA life. I have not stopped and probably never will stop trying to understand the program better. But my priority is the utilization of the program to make my life fuller, richer, more serene. All this has meant for me, finally, is that sometimes truths oversimplified can become half-truths. And I prefer my truths to be whole.

better delegates, we need better district committee members. If we want better district committee members, we need better GSRs." Practically all our service people, including the alcoholic trustees on AAs General Service Board, come from that potentially ample pool of GSRs. Yet of our 17,819 reported groups in the United States and Canada, a large proportion do not elect GSRs. And how carelessly some groups choose their GSRs; once the groups have chosen, how little encouragement and guidance they offer. As a new GSR, attending my first district meeting, I began to grasp, at gut level, the tremendous extent of AA. Intellectually, of course, I had known that AA was more than my home group and the few groups in the immediate vicinity. But in AA service sessions, I began to feel it emotionally, and it became real. I heard the current delegate and past delegates talk about the annual General Service Conference in New York, and they communicated to me their excitement and gratitude at being a part of this tremendous, worldwide Fellowship. Not all the GSRs shared my excitement, however. Many were confused and bored. They did not know why they were there. Some did not even care, and dropped out—often without the formality of an honest resignation. Many groups think they have a GSR because they elected one "a while back." I learned that some of the groups did not even ask their GSRs for reports on district or area meetings. The more eager and responsible GSRs were often brushed aside or given very little time for their reports. This kind of treatment is discouraging to the GSR. It shows respect neither for a fellow AA nor for the essential AA service structure upon which the recovery of millions of suffering alcoholics eventually depends. During

my own first few weeks as GSR, I, too, had Trouble getting time for my announcements.

Then I made some blackboards out of panels of Masonite, two feet by four feet. I hung them on a wall in front of the room, and wrote pertinent information on them. While members listened to the speaker, they couldn't help seeing the boards. When the chairman called for announcements about the next meeting, I'd make some announcements about service whether it concerned the meeting or not. Eventually, group members would automatically look at me when the leader asked if there were any announcements, because they knew I'd have one. In The AA Service Manual, Bill W. defines AA service as anything that helps us reach a fellow sufferer. Bill lists Twelfth Step calls, a cup of coffee, and on to AA's General Service Office and Board for national and international action, pamphlets, books, and this magazine, the Grapevine. In St. Louis in 1955, Bill—the surviving co-founder—turned AA over to the membership. As Bill phrased it, AA had come of age. I don't believe that we have ever fully accepted that responsibility in all these twenty-one years. The General Service Conference is the ultimate acceptance of our responsibility for survival of AA. The quality of the delegates we send to that Conference is determined by the quality of the members we choose as GSRs.

SELF-SUPPORT-September 2017

© Today in September of 2017 we have 224 Groups with 565 meetings a week. Contributions in September totaled \$ 3,221.06. That accounts for what 29 Groups and 2 Individuals out of 224 Groups in our area have contributed in September. Our total income for September was \$11,478.11. Our Cost of Goods Sold was \$6,253.90. Subtracting the Cost of Goods Sold from our September income left us with a Gross Profit of \$5,224.21. Our Total Expenses for September were \$7,913.35. Subtracting our Expenses from our Gross Profit gave us a Net Income of minus—\$2,689.14 for the month of September. This leaves us a total of minus—\$2,795.76 in the red for the year thus far. No matter how good or bad it may appear that we are doing from one month to another, it takes your consistent contributions to keep us operating on a steady level. As our AA membership continues to grow in the Tampa Bay area, the demand for more and more material and services continue to expand and we continue to try and strive to keep up with the demand. That is only possible with your continued support . Thank you for all of your support !!!


