IS CENTRAL OFFICE PART OF AA?

I should be used to this by now, but every once in a while a newcomer or sometimes, someone who has been in A.A. for quite some time will be at a meeting and will ask the question. "Is Central Office part of Alcoholics Anonymous"? If anyone answers the question, you'll probably hear one person say yes and another person say no. I was taught in the very beginning of my journey into Alcoholics Anonymous not to put too much faith in many things said at an AA meeting. I don't know about you, but when I came in to AA, I really wasn't "wrapped too tightly" and I later came to realize that I wasn't alone. If you know what I mean:) I was told that if I couldn't find it "in the book", don't believe it. Yes, there are many good people in AA and they definitely have a lot of good things to say, but when it comes to the Truth about AA history and our Traditions rather than someone's personal opinion, if you want the Truth—I say study our literature. Tradition Eight: Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers. Tradition Nine: A.A. as such, ought never be organized; but we may create service boards or committees directly responsible to those they service. In 1975, after many years of supporting different variations of a service center, 44 AA groups in the Tampa area got together and formed Tri-County Central Office. The General Service Guidelines state that a Central Office is an A.A. service office that involves partnership among groups in a community—just as A.A. groups themselves are partnerships of individuals. The Central Office is established to carry out certain functions common to all groups—functions which are best handled by a centralized office—and it is usually maintained, supervised, and supported by these groups in their general interest. It exists to aid the groups in their common purpose of carrying the A.A. message to the alcoholic who still suffers. There are nearly 1000 central/intergroup offices throughout the world, performing vital A.A. services. These constitute a network of service outlets and A.A. contacts to help carry the A.A. message. By providing an Alcoholics Anonymous listing in the local telephone directory, the Central Office may receive inquires from those seeking help. The Central Office maintains a conveniently located office in which a paid worker is available to refer the caller to a nearby A.A. group or have a Twelve-Stepper contact them. *The paid worker* is not being paid to do Twelve Step work, he is being paid to maintain the office. Tri-County Central Office also states that at regular intervals, the Central Office publishes up-to-date lists of meetings and a monthly newsletter. The Central Office also functions as a clearinghouse for the circulation and exchange of information among the A.A. groups in the community, and is an ideal contact with the public and professionals in the alcoholism field, the District General Service and it's different committees, the South Florida Area General Go to Page 3

Growth of Central Offices

The Jack Alexander article in the Saturday Evening Post not only began a large influx of prospective members into AA, it began a new phenomenon. This new concept in AA was the beginning of Central Offices and Intergroups. On March 2, 1941 a "Clearing House Committee" was formed in Cleveland, Ohio. This was an outgrowth of the AA Association which was formed in the late summer or early fall of 1939. The AA Association helped keep records of those prospects who were hospitalized for detoxification in the Cleveland area. It also was responsible for making sure all hospital bills were paid. The Clearing House Committee was comprised of two (2) members from each and every AA Group in Cuyahoga County. The motion that created this committee stated that "This Committee to have NO AUTHORITY to commit, involve or bind any one or all of the Groups in Cuyahoga County in any manner whatsoever without first referring proposed ideas, plans or prepositions to each individual Group for its acceptance or rejection." In New York City, the AA Clubhouse on 334 1/2 West 24th Street was established in 1940. This was the hub of AA activity on the local level. In 1942, the first New York City Central Committee was formed to handle inquiries from new prospects. They hired two (2) secretaries who were responsible for answering letters and phone calls. The New Jersey meetings were also using the Clubhouse on West 24th Street as their headquarters. Meetings in New Jersey, started by Hank P. began in 1936. Even though these weren't officially, AA meetings. AA grew in New Jersev until it was necessary to form their own Central Committee in 1944. First Newsletters Many Central Offices or Committees were formed around clubhouses until they could move out and pay rent on office space. These committees helped consolidate the "business" end of AA work and maintain a local telephone contact number for prospective members as well as publishing their own literature. AA's first newsletter was the Cleveland Central Bulletin. Its publication began in October, 1942. It was an outgrowth of the mimeographed "Bulletin to all Groups" as a way of sending information not only to the Cleveland, Ohio Groups, but to the Cleveland AA members serving in the armed services. The New York headquarters liked the Central Bulletin so much that they began publishing their own "meeting in print" in 1944 - The Grapevine. Throughout the 1940's, AA Central Offices sprung up around the country as AA membership and the number of Groups grew. Each one had their own set of rules and regulations affecting local groups. Some areas even had rival Central Committees due to one faction not agreeing with the other one's rules. The long heard Rule 62 story probably came about as a result of all of these rules and regulations. If all the rules were put into effect by AA, no alcoholic would qualify for membership in Alcoholics Anonymous. One story has it that a group responded to some questions posed to Go to Page 3

One story has it that a group responded to some questions posed to them by Bill W. by stating that they are all doing well. The members of that group were no longer drinking hard liquor and only drinking beer. They thought that this was a great accomplishment for hard-core alcoholics. The AA Club in Springfield, Missouri was raided by the police on August 25, 1948 and seven members were arrested, tried and convicted for gambling. Even though there was a 10 cent limit on bets, the police still considered it gambling. The Central Committee, Central Office and Intergroup are all part of AA's history and continue to be an integral part of AA's growth. Local telephone services handle thousands of calls for help on a daily basis all around the world. Many use AA members to answer the phones and some use professional answering services who either give out meeting information or refer the calls to a local AA member. Many of these committees or offices coordinate local activities, publish local literature and order conference-approved literature in quantity so that they may pass along the volume discount to the groups. Unfortunately, many areas do not understand the importance of Central Offices or Intergroups and financial support for them is not forthcoming. These offices are often the lifeline for the still sick and suffering alcoholic who reaches out for help. More will be revealed...

EASE OF SOBRIETY

Happy sobriety is not the result of not drinking. It is the result of a new way of life. We cannot live a new life in the way that we used to live the old one. To think that we can is like thinking that we can control our drinking. The habits of the old life are not compatible with those of the new one and the new one, because it is new, is simple. When our ego is finally busted and our sick will completely broken we become aware, often very gradually, of a supreme power which makes the program of Alcoholics Anonymous work. With this growing awareness that we are not God we are enabled to receive forgiveness and love. Thus cleansed by this feeling of forgiveness, relaxed and strengthened by this love, we are able to start the adventure of living with gratitude and simple trust. Whereas before, in our drinking days, every detail was a problem, now most problems are detail. They are that way to God. They will stay that way unless we wrestle with them. God salvaged the human wreckage which was us and one way or another, in spite of ourselves, shunted us into Alcoholics Anonymous. We do not know why, but we know it is intended for us to be happy in our new way of life and that to maintain our happiness we must seek to share it. It is a simple rule that when we give we get, and we can give to anyone, anywhere, any time. The day is bulging with opportunity. The day is as good as we let it be. I read in the Big Book one short sentence in the chapter "Into Action." It says, "We don't struggle." To struggle means to take every opportunity and turn it into a problem which cannot be solved. To struggle means to clutch to ourselves fear, pride, shame, remorse, jealousy, dishonesty, conceit and selfishness; to make a great show of overcoming; and then, in an orgy of self-pity, to be overcome. If that is what we want we can get it straight and quickly in one short drink, a drink that will never, never end. But we want it no more because we have learned through experience a truth which cannot be refuted, a living truth which is responsible for the pulse-beat at our wrists today: that we were specially blessed people made to live abundantly, and more abundantly still, made to know humility—and joy—and new life. Our life is made worthwhile. It takes time to learn to live the new way. It takes time to uncomplicated ourselves. It takes experience to learn by experience. It takes just as long as it takes—but meanwhile with our new-found gifts of honesty, open-mindedness and willingness we are very much taken up in something which we had no part of before: living life in the world as it is, and liking it. Our selfishness begins to fall away through neglect as we start giving of what we have, and the least of what we have in AA is hope for the hopeless and love for the loveless. The program of AA is unlimited. It's healing action is infinite. Moreover it is not intricate. It is simple, straight-forward and proven. It works.

SELF-SUPPORT-January, 2019

© Today in January of 2019 we have 226 Groups with 567 meetings a week. Contributions in January totaled \$ 6,747.84. This accounts for what 51 Groups or individuals in our area have contributed in January. Included we also received \$248.00 from the Birthday Club, \$5.00 for 1 Big Book Raffle ticket, \$135.00 for 9 Anniversary Dinner tickets. Our total income for January was \$13,389.74. Our Cost of Goods Sold was \$4,803.97. Subtracting the Cost of Goods Sold from our January income left us with a Gross Profit of \$ 8,585.97. Our Total Expenses for January were \$ 10,159.49. Subtracting our Expenses from our Gross Profit gave us a Net Income of minus-\$ 1,573.52 for the month of January. But as they say in the rooms of AA "this too shall past." No matter how good or bad it may appear that we are doing from one month to another, it takes your consistent contributions to keep us operating on a steady level. As our AA membership continues to grow in the Tampa Bay area, the demand for more and more material and expand and we continue to try and strive to services continue to keep up with the demand. 
