Growth of Central Offices

The Jack Alexander article in the Saturday Evening Post not only began a large influx of prospective members into AA, it began a new phenomenon. This new concept in AA was the beginning of Central Offices and Intergroups. On March 2, 1941 a "Clearing House Committee" was formed in Cleveland, Ohio. This was an outgrowth of the AA Association which was formed in the late summer or early fall of 1939. The AA Association helped keep records of those prospects who were hospitalized for detoxification in the Cleveland area. It also was responsible for making sure all hospital bills were paid. The Clearing House Committee was comprised of two (2) members from each and every AA Group in Cuyahoga County. The motion that created this committee stated that "This Committee to have NO AUTHORITY to commit, involve or bind any one or all of the Groups in Cuyahoga County in any manner whatsoever without first referring proposed ideas, plans or prepositions to each individual Group for its acceptance or rejection." In New York City, the AA Clubhouse on 334 1/2 West 24th Street was established in 1940. This was the hub of AA activity on the local level. In 1942, the first New York City Central Committee was formed to handle inquiries from new prospects. They hired two (2) secretaries who were responsible for answering letters and phone calls. The New Jersey meetings were also using the Clubhouse on West 24th Street as their headquarters. Meetings in New Jersey, started by Hank P. began in 1936. Even though these weren't officially, AA meetings, AA grew in New Jersey until it was necessary to form their own Central Committee in 1944.

First Newsletters

Many Central Offices or Committees were formed around clubhouses until they could move out and pay rent on office space. These committees helped consolidate the "business" end of AA work and maintain a local telephone contact number for prospective members as well as publishing their own literature. AA's first newsletter was the **Cleveland Central Bulletin**. Its publication began in October, 1942. It was an outgrowth of the mimeographed "Bulletin to all Groups" as a way of sending information not only to the Cleveland, Ohio Groups, but to the Cleveland AA members serving in the armed services. The New York headquarters liked the Central Bulletin so much that they began publishing their own "meeting in print" in 1944 - The Grapevine. Throughout the 1940's, AA Central Offices sprung up around the country as AA membership and the number of Groups grew. Each one had their own set of rules and regulations affecting local groups. Some areas even had rival Central Committees due to one faction not agreeing with the other one's rules. The long heard Rule 62 story probably came about as a result of all of these rules and regulations. If all the rules were put into effect by AA, no alcoholic would qualify for membership in Alcoholics Anonymous. One story has it that a group responded to some questions posed to them by Bill W. by stating that they are all doing well. The members of that group were no longer drinking hard liquor and only drinking beer.

Good Meeting Ingredients

Where does AA flourish at it's best? We've attended meetings at a fairly representative number of cities; in large cities and in small towns; with large groups and small groups; with old groups and new groups. Alcoholics are the same wherever you find them. In other words, each group is composed of the same raw material. The fact that different results are obtained by groups must be due to the refining process. Numerous factors determine what quality of grist will come out of the AA Grinding Mill. Offhand, we can name four important factors—group fellowship; group co-operation; group sponsorship; and group leadership. No matter how fully and ably we may explain the AA program, the candidate's success will still depend largely on how much those four factors are in evidence. There is one more thing each group should and must have to be successful. That is interesting meetings, the kind of meetings that each member looks forward to attending. He must want to go, and he must like to go. Surely, the AA principles are the most important, but you can't explain the principles to people who are not at the meetings. It must not be a prayer meeting, nor can it be a clambake; it must not be a discussion of theology and metaphysics, nor can it be a recitation of the lurid and unlovely episodes of our dead past. There must be a neat balance at a sane level. Meetings can be serious without being depressing. They can be humorous without being offensive. They can be educational without being pedagogical. They can provide hope without promising the millennium. They can be a forum for sane and general discussion of problems without degenerating into pandemonium. **Anonymous**

Dan S. read the list of treatment facilities and information he had gathered regarding contacts and asked for updates from the committee. Some information was provided. Dan S. indicated he had received the listing Ed D. compiled in March 2020 and would continue to contact people named on the list and to update it. Tom F. mentioned that the updated list could be posted to the TBAIC web site. **INSTITUTION MEETING UPDATES** Tom F. said no jail or prison meetings due to COVID-19. Jill K. said she reached out to a friend who works at the DACCO Women's facility to get an updated contact person. No face to face or Zoom meetings currently being held there. Lance A. said he is AA contact for meetings at the Board Prep Treatment Center on Kennedy Blvd. Meetings are on Monday between 7 and 8 PM with a maximum of 3 outsiders – 1 chair and 2 speakers. Hezekiah D. said officials at W.T. Edward Juvenile facility approved him carrying meetings into the facility. The first meeting is scheduled for January 28th. Meetings will be held Thursday between 7 and 8 PM. He also indicated the Robert M. had expressed an interest in attending meetings there and he had been fingerprinted and approval is pending. He said meetings will not be started until Robert is approved.

They thought that this was a great accomplishment for hard-core alcoholics. The AA Club in Springfield, Missouri was raided by the police on August 25, 1948 and seven members were arrested, tried and convicted for gambling. Even though there was a 10 cent limit on bets, the police still considered it gambling. The Central Committee, Central Office and Intergroup are all part of AA's history and continue to be an integral part of AA's growth. Local telephone services handle thousands of calls for help on a daily basis all around the world. Many use AA members to answer the phones and some use professional answering services who either give out meeting information or refer the calls to a local AA member. Many of these committees or offices coordinate local activities, publish local literature and order conference-approved literature in quantity so that they may pass along the volume discount to the groups. Unfortunately, many areas do not understand the importance of Central Offices or Intergroups and financial support for them is not forthcoming. These offices are often the lifeline for the still sick and suffering alcoholic who reaches out for help.

ALONE WITH ME

On the finer points of isolation

We have all done it. Many of us isolated when we drank, and some still do in sobriety. We may dress it up as "hibernating" or "being alone," but it is usually not a positive thing. Generally, I am not good company for myself. Being accountable to my sponsor and other AAs keeps me from staying in isolation too long.

I always choose isolation. I even plan it. Maybe I did not get what I wanted, or maybe something "unfair" happened. I am different, I think, and misunderstood. I stop calling people and quit answering my phone. I go to different meetings where I can avoid communication and advice because people don't know me. I pray with a bit of anger and read my meditations with a sarcastic attitude. Bad thinking and isolation lead me to negativity. Neither will help get me closer to my Higher Power or help me grow.

My sponsor has helped me see that isolating is partially an act of self-pity. If I don't think I am being treated fairly, I pout and brood as I did when I drank. I am unwilling to be honest with myself. I isolate so that no one can challenge my thinking, and because I am unwilling to see any other viewpoint. I want to think in a narrow-minded and negative way. I spent many years doing this before I came to AA. But each year sober, I isolate less. It is non-productive, destructive, and immature. After all, I'm fifty years old, and it's time to grow up!

Isolating not only keeps people out, it shuts me out from the light. I need that light and its power in order to grow. By making myself accountable at meetings, sponsoring other women, doing service, practicing the Steps, and regularly attending my home group, I stay connected to AA and my periods of isolation are limited or nonexistent.

JUDGE NOT....

At times we run into disappointments. Someone we thought was an ideal member of AA suddenly takes on a different roll. We fail to realize or remember that we are only a group of individuals and that we all have different ways of staying sober and working the program. So when we hear something about a guy who had been a leader in our organization and a guy whom we have for many years looked up to and respected, it makes it hard for us to accept some of the things that we think of in regard to our Twelve Steps. Then we suddenly realize that it doesn't make any difference to us, that the way some one else stays sober is none of our business. The only thing that should concern us is how do we stay sober and practice the principles of the Twelve Steps in our daily program. When we look in the glass that is the guy we have to satisfy and not the other guys who maybe we can't quite understand how they can do the things that they have done. So after all, why should we even so much as let the thought enter our heads that that guy isn't doing right. If he isn't, he is the guy that will know; he's the guy that he has to satisfy. If we let what he does bother us, then we are in danger of taking a drink because the old resentments must be coming back again; and they are something that all of us have been bothered with for years. Let's just be thankful that we are sober and that we have our Twelve Steps to turn to and show us the way to go on living a good life regardless of the things that we hear and see going on around us. After all, who are we to judge? Maybe to some this is hard to do, but I think it is the hard things we have to do that denote our growth on the AA program which is our salvation. Let's all try to do a better job of living this program and practicing these principles in all our affairs all of the time.

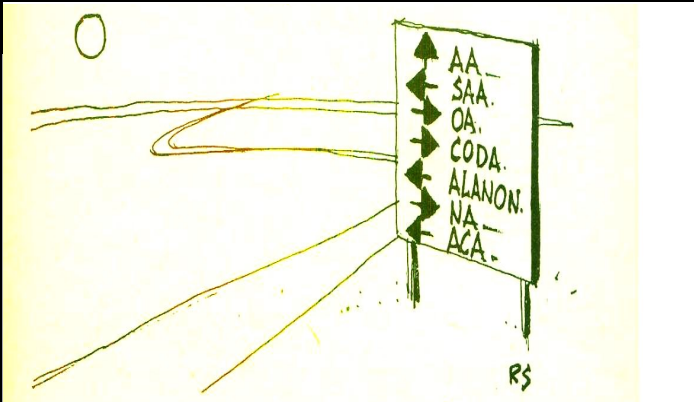

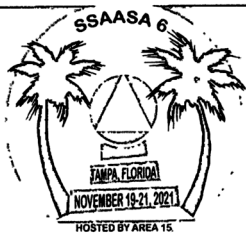

SELF-SUPPORT-January 2021

© Today in January of 2021 COVID has changed the way many groups contribute to the Central Office. Some groups have remained steady in their contributions, some groups have gone to ZOOM, A few ZOOM groups have made some contributions and other groups have folded for a lack of a space to have their meeting. It's certainly a time to renew our efforts and practice the meaning of the Serenity Prayer a little bit more. Contributions in January totaled \$ 5,228.37. This accounts for what 57 Groups or individuals in our area have contributed in January. 17 of those contributions were for less than \$3.00. Included we also received \$172.00 from 3 members for the Birthday Club. Our literature sales for January was \$ 3,689.98. This includes sales from A.A. material and non-A.A. material (medallions—etc.) Our total income for January was \$ 9,032.66. Our Total Cost of Goods Sold was \$ 2,789.84. Subtracting the Total Cost of Goods Sold from our January income left us with a Gross Profit of \$ 6,242.84. Our Total Expenses for January were \$ 8,473.91. Subtracting our Expenses from our Gross Profit gave us a Net Income of minus-\$ 2,231.07 for the month of January. As a reminder, we now have a contribution button on our web site www.aatampa-area.org, it's nice, but they do charge us a fee, so unfortunately not all of your contribution gets dispersed to the Central Office. Sending in your contribution by check or money order or coming by the Office with cash is even better. At the end of December, we were completely out of Twelve & Twelve hard covers and soft cover books, Big Book soft cover books and had only two cases of hard cover Big Books left in inventory. Fortunately, a few generous helped us through the hump and we are now fairly well stocked In spite of the COVID-19 virus, we are still trudging the happy road of destiny and our groups are still continuing to support us however they can and we deeply appreciate any effort made for us. Many meetings are still live, but many have gone to ZOOM for the time being due to the requirements of the facility that they meet in. We thank you for your continuing support. As they say in the rooms of AA "this too shall past." And this virus will. No matter *how good or bad* it may appear that we are doing from one month to another, it takes your consistent contributions and support to keep us operating on a steady level. As our AA membership continues to grow in the Tampa Bay area, the demand for more and more material and services continue to expand and we continue to try and strive to keep up with the demand. That is only possible with your continued support. Thank you for all of your support !!!

The Birthday Club: Contributions to the Central Office help support the local services to members and groups throughout Hillsborough and East Pasco Counties and help ensure that the A.A. message is carried around our area. Members customarily contribute \$1, \$2 or even \$5 a year for each year of sobriety—others may give a penny or a nickel a day for each day of their sobriety. Ask your Treasurer if they have any Birthday envelopes available.
