Take the case of the club janitor and cook. If the club is going to function, it has to be habitable and hospitable. We tried volunteers, who were quickly disenchanted with sweeping floors and brewing coffee seven days a week. They just didn't show up. Even more important, an empty club couldn't answer its telephone, but it was an open invitation to a drunk on a binge who possessed a spare key. So somebody had to look after the place full time. If we hired an alcoholic, he'd receive only what we'd have to pay a non-alcoholic for the same job. The job was not to do Twelfth Step work; it was to make Twelfth Step work possible. It was a service proposition, pure and simple. Neither could A.A. itself function without full-time workers. At the Foundation (General Service Office in New York) and

They pay little attention to the talks and discussions-except to criticize-and the talks and the discussions themselves are left exactly where they found themsermon was not over: now you tell me the minister has left the pulpit. Mike B. opened the July 9, 2022, TBAIC Zoom meeting with the Declaration of Unity. Attendees: Mike B., Sara R., Scott S., John O., Tom F., Tracy S., Jonathan C., Jason C., Rich R., Jasmine L., and John T. Mike B. presented the chair report. Mike B. said he recently received a pre-release contact form for a man due to be released from a correctional facility in Arkansas who was coming to the Land O'Lakes area. He said he asked Tom F. to communicate with the individual. Mike also mentioned the request from the Tampa US Probation Officer which he said would be discussed under New Business. He said he attended the recent district meeting and gave a synopsis of the meeting. He added that he and John O. (incoming chairperson) would be attending the treatment and corrections committees' workshops at the upcoming area quarterly meeting in Miami. Mike said minutes of the district meeting and agenda for the area quarterly meetings would be sent out with minutes of this meeting. Jasmine L. was a new attendee at the meeting. She indicated she was the committee rep for the Live and Let Live group, and she was interested in how the committee functioned. Jasmine said she had previously contacted John T. and he provided her a list of service opportunities which she said she would share with her home group members. John T. asked if there were any questions or comments regarding the June minutes. Nothing was mentioned. The minutes were approved. Scott S. presented the treasurer's report. The current Pink Can balance is \$7,202.22. Contributions for the month totaled \$201.57. Operating expenses totaled \$140.87 and literature purchases totaled \$3,373.19. Scott said most of the literature purchases were made to replenish the supply in the TBAIC cabinets at central office. The report was approved. INSTITUTION MEETINGS UPDATES Treatment facilities meetings:
ACTS Amethyst – John T. said volunteers have committed to chair 13 live and 1 Zoom meeting. He said the chairperson for one meeting changed but no other changes.

ACTS Detox – John T. said chairpersons are still needed for noon time meetings on Monday, Tuesday, and some Saturdays. He said someone volunteered to chair the noon time meetings on the 3rd Saturday of each month but a volunteer is still needed for the other Saturdays.
ACTS Sandra Prince Intermediate Care Program – John T. said volunteers are needed to chair meetings at both the 17th St and 131st Ave facilities.
Cove Behavioral Health (formerly DACCO). Both men's and women's meetings have restarted. John said a new volunteer (John N.) is chairing the men's meeting and volunteers are needed for that meeting. \Box HCA Florida West Tampa Hospital Detox (formerly Tampa Community Hospital or Town and Country Hospital). Tom F. said Jason C. started meetings at the facility and Tom said he would be starting to attend meetings there.
Selah House. John T. said Liz S. picked up literature for the facility and indicated that if females are interested in volunteering to chair/attend meetings to contact her. The facility is a safe house for victims of human trafficking.

River Oaks. Jason C. said Monday, Wednesday and Friday meetings are going well. Corrections facilities meetings: Falkenburg Road Women's Jail - Sara R. said jail management has begun to emphasize the need for all court ordered inmates to attend meetings. As a result, volunteer inmate attendees would be limited. Sara said a recent Sunday meeting had 15 court ordered and 7 inmate volunteer attendees. Sara said she discussed the possibility of adding a second meeting but none of the AA volunteers seem interested in doing that. Sara also said she was told that they could no longer bring AA literature such as Big Books and Grapevine magazines into meetings. She said she had a case of hard copy Big Books which she could either keep for future use or return to the TBAIC literature cabinet. Several committee members indicated that Sara should hold onto the books in the event the jail changes their policy.
□ Falkenburg Road Men's Jail – Rich R. said the Sunday morning meeting was switched to Friday 2pm. He said there would no longer be a Sunday morning meeting. He added that the jail emphasis on having court ordered attendees going to meetings increased meeting attendance. He said he and 2 other volunteers are handling the meetings. He said he has been bringing AA literature to meetings with no objections by jail management.
Zephyrhills CI –Tom F. stated all is going well. He said 18 inmates attended the last meeting. He said the meeting was granted permission to make and serve coffee at meetings and he believed that helped to increase attendance. He said a long-time inmate attendee has asked him if it would be possible to get the Daily Reflections daily reading sent to

him and others through the prison email system. Tom said he was working on that.
True Core Behavioral. Jason C. said he will meet with facility management this Thursday and anticipates that meetings will be starting in the next few weeks. He said 3 female and 3 male volunteers have been cleared to attend meeting but that additional female volunteers are welcome. Tom F. said he may consider posting a notice on the Tampa AA Facebook group for volunteers. Jason said he would look into that. Bridging the Gap - Tracy S. said she got 1 call in June which she asked John T. to handle. John said the call back number was at ACTS Detox and when he called back no one there knew of the individual who called. Tracy said she received 4 messages via Ring Central so far this month. She said she called back 2 individuals and left messages with no call back and the other 2 were calls from institutions which were called back and could not determine who made the call. Mike B. said he received a call from an individual in Pinellas County who asked him to go visit a patient at a facility in Lutz. Mike said he tried to explain to the individual that he would need to contact someone else to do so. However, the individual became agitated and hung up the phone and could not be re-contacted. John O. asked to be added to the call list and Mike said he would do that. Tracy said she had a sponsee who would like to be added to the list and said she would provide her information to Mike. Man on the Bed - Tom F. said 2 calls from Tampa General. He said when the individuals were contacted by AA volunteers, they both said they did not want any help from AA. OLD BUSINESS: Mike B. said he will delay making an offer to other districts to provide them literature given the current Pink Can balance and recent spending for literature. Mike also said volunteers are always needed as noted above. NEW BUSINESS: US Probation Officer request for AA meeting at Tampa residential facility. Mike mentioned the email he received. Several members spoke in favor of doing the meetings, but further details are needed. John T. volunteered to contact the email sender and provide details to committee members. Scott S. went over the list of AA pamphlets he had purchased in the past and asked if there were any others that should be added to the supply in the TBAIC cabinets at the central office. Several additional pamphlets were mentioned, and Scott agreed to purchase those. Jonathan C. mentioned an incident he recently had with management at ACTS Detox. He said he and 5 other volunteers entered the facility. He said an unknown individual who identified herself as a manager indicated that only 2 volunteers at a time were allowed in the facility. Jonathan asked if anyone had experienced anything like that. John T. said that several months back, the program director at ACTS Amethyst had asked that no more the 2 outside AA volunteers attend meetings due to space limitations and social distancing requirements related to Covid-19. John said the former meeting coordinator for ACTS Detox expressed a similar concern. Jonathan said he was not aware of that requirement but said he would follow it in the future. Meeting adjourned with the Responsibility Statement and the Lord's Prayer. The next TBAIC meeting will be Saturday, August 13th, at 9:30 AM via Zoom.

intergroup offices, we couldn't employ non-alcoholics as secretaries; we had to have people who knew the A.A. pitch. But the minute we hired them, the ultraconservative and fearful ones shrilled, "Professionalism!" At one period, the status of these faithful servants was almost unbearable. They weren't asked to speak at A.A. meetings because they were "making money out of A.A." At times, they were actually shunned by fellow members. Even the charitably disposed described them as "a necessary evil." Committees took full advantage of this attitude to depress their salaries. They could regain some measure of virtue, it was thought, if they worked for A.A. real cheap. These notions persisted for years. Then we saw that if a hardworking secretary answered the phone dozens of times a day, listened to twenty wailing wives, arranged hospitalization and got sponsorship for ten newcomers, and was gently diplomatic with the irate drunk who complained about the job she was doing and how she was overpaid, then such a person could surely not be called a professional A.A. She was not professionalizing the Twelfth Step; she was just making it possible. Perhaps the fear will always lurk in every A.A. heart that one day our name will be exploited by somebody for real cash. Even the suggestion of such a thing never fails to whip up a hurricane, and we have discovered that hurricanes have a way of mauling with equal severity both he just and the unjust. They are always unreasonable.	Now we need more action, without which we find that "Faith without works is dead." Let's look at <i>Steps Eight and Nine.</i> We have a list of all persons we have harmed and to whom we are willing to make amends. We made it when we took inventory. We subjected ourselves to a drastic self-appraisal. Now we go out to our fellows and repair the damage done in the past. We attempt to sweep away the debris which has accumulated out of our effort to live on self-will and run the show ourselves. If we haven't the will to do this, we ask until it comes. Remember it was agreed at the beginning <i>we would go to any lengths for victory over alcohol.</i> Probably there are still some misgivings. As we look over the list of business acquaintances and friends we have hurt, we may feel diffident about going to some of them on a spiritual basis. Let us be reassured. To some people we need not, and probably should not emphasize the spiritual feature on our first approach. We might prejudice them. At the moment we are trying to put our lives in order. But this is not an end in itself. Our real purpose is to fit ourselves to be of maximum service to God and the people about us. It is seldom wise to approach an individual, who still smarts from our injustice to him, and announce that we have gone religious. In the prize ring, this would be called leading with the chin. Why lay ourselves open to being branded fanatics or religious bores? We may kill a future opportunity to carry a beneficial message. But our man is sure to be impressed with a sincere desire to set right the wrong. He is going to be more interested in a demonstration of good will than in our talk of

Spiritual as it is, A.A. remains very much of this world. The Eight Tradition, like the Seventh Tradition, focuses on a vulgar five-letter word that isn't actually mentioned in either: <i>money</i> . Many of us have had to explain to some cynical prospect, "No, I'm not a social worker. I don't get paid for talking with you. I'm doing it because it's the best way to stay sober for myself." This does not mean, of course, that the idea of turning professional has never entered any A.A.'s mind. In the lean years, Bill W. did think of becoming a lay therapist to earn money through his experience in helping alcoholics. But, with a strong nudge from the group conscience, he soon realized that he could never hang out a shingle reading "Bill W., AA Therapist, \$10.00 an Hour"! It became clear to the early	toward him, we are still not too keen about admitting our faults. Nevertheless, with a person we dislike, we take the bit in our teeth. It is harder to go to an enemy than to a friend, but we find it much more beneficial to us. We go to him in a helpful and forgiving spirit, confessing our former ill feeling and expressing our regret. Under no condition do we criticize such a person or argue. Simply we tell him that we will never get over drinking until we have done our utmost to straighten out the past. We are there to sweep off our side of the street, realizing that nothing worth while can be accomplished until we do so, never trying to tell him what he should do. His faults are not discussed. We stick to our own. If our manner is calm, frank, and open, we will be gratified with the result.


