Some Central Office, Tampa AA History

Memory at best is a tricky thing. Already the legend is that AA sprang into full bloom in Tampa in January 1944 -- eighteen years ago. The facts are that AA in Tampa will have been in existence twenty years on April 13, 1942. This History was first thought of in Miami in 1960. The writer was talking to a Miami AA friend who related that he had contacted the General Service Office of Alcoholics Anonymous in New York, asking for their views on New York co-operating with Miami in compiling an authentic history of Miami AA. New York responded very graciously, sending photo static copies of the original correspondence emanating from Miami in 1941 -- and New York's replies. On November 11, 1960, the writer contacted Mrs. Lyb S. of the General Service Office in New York City, asking them for their views on the subject. The response was gratifying -- to say the least. In January of 1961, Nell W. -- Bill W.'s (our Co -Founder) non-alcoholic Secretary and "Keeper of the Historical Files" sent me thirty- eight (38) photo static copies of the original correspondence from Tampa, dating from April 13, 1942 through the year 1952 -- a period of ten years. The writer has copied profusely from these early letters, in order to present this History in chronological form. These statements from letters in quotes are verbatim. Any Doubting Thomas can verify this by contacting the writer. They are now a part of Tampa's Historical File, now in possession of the writer. This History is not for the general public. It is a history of Alcoholics Anonymous in Tampa, written by an alcoholic, for the information of those alcoholics that are interested -- and for an "honest" History fully documented and authenticated. In her letter of transmittal, Nell W. writes: "Generally speaking, perhaps we shouldn't release the original correspondence in our files. We have always made the point that letters to us are held in confidence and, of course, it is right that we do this. "However, when we receive requests for historical material, I don't believe it breaks a confidence to provide factual information for this purpose contained in correspondence to this office. Therefore, I'm sending excerpts from letters (editing only those portions that deal with personal problems, or personal opinions, or just plain wordiness). Also I'm sending along the very early activities of AA in Tampa, in full, so that you will have a better picture of what happened before Roy Y's appearance there in 1944." (Note: Writer's interlineations) Some AA's in Tampa are not going to like what they read. Some are going to "holler" loud and long that " 't isn't so." Some are going to have their feelings ruffled, because they have built up a beautiful legend, full of pious thoughts and good deeds, of how AA in Tampa came full blown into being. Some of this History is not a "pretty" picture. Some of it is grim. Some of it is downright "ugly" in the telling. While writing these ugly, sordid, "commercialization of AA" details, I have done so with the thought that it is History; and if History is written honestly, then the "ugly" must be recorded. It is a Historian's duty to record facts, not fables. We alcoholics are not "pretty" people before we get on the program. Some of us have gone so far down that our sense of moral values has badly deteriorated. And we are still not "pretty" people, even after years of 'so-called" sobriety, unless we change our entire life, as called for by the AA program. This portion of the History, which I saw, or heard of the next day, I have written as Go to Page 3

Some Tampa A.A History

As far back as 1942---80 years ago---A.A. had arrived in Tampa. The first contact made by anyone from Tampa was by a letter written to Alcoholics Anonymous, P.O. Box 658, Church Street Annex, New York, on April 13, 1942 by Helen Devereux, 3911 Drexel Avenue, Tampa, Florida. She wrote that her husband --William S.D., -- was an alcoholic who had joined AA in Chicago, Illinois, in 1941; that it had helped him so much that he wanted to try to start an AA Group in Tampa. Bill had been transferred from Chicago to Tampa and represented the Beltraction Company, which had been formed by Bill and his brothers in Chicago. In July 1942 appeared the first advertisement in the Tampa Area. Helen wrote the Foundation on July 30, 1942 that she had a small "ad" in the Tampa Times and the Sunday Morning Tampa Tribune as follows: "Alcoholics You Can Be Cured. No Money Or Medicine Phone W-3157". On August 3, 1942 Bobbie wrote Helen, and among other things stated: 'Sounds like you are really going to town with the advertisements, etc., in the papers. How is Mr. Devereux taking all of it? May we make one suggestion -- in any future advertisement that you run? That is -- not use the word "cure" but to put "recovery" in its place. Perhaps it will run like this -- "Alcoholics -- you can make a recovery." By 1946 there were 100 members among four groups. In 1942 the Central Office (then called Central Headquarters) was located at 409 South MacDill Avenue and later at West Lafayette Street. It closed after 18 months and an answering service was set up to alert members to 12 Step calls. In 1948, Central Office moved to the "Red Star Hotel", on Tampa Street, just two blocks from Tampa's "skid row. Later, in 1956, with 15 A.A. groups, a clubroom and Intergroup were set up on the second level of a beer distribution warehouse at 1706 Grand Central Avenue, now called Kennedy Boulevard. Early on telephone calls were answered by a taped message instructing callers to dial another number --- that of a 12<sup>th</sup> Step Volunteer. In December of 1974 a series of meetings held by interested members created an effective means of carrying the A.A. message. From those gatherings arose the Tri-County Central Office as we know it today. Seventeen groups participated in the planning and a non-profit corporation was formed By early 1975 an office was set up at 2307 Azeele Street. From there it was moved to North Florida Avenue and then to Grand Central Avenue. In February of 1989 the Central Office moved to the Lago Vista Building at 8019 North Himes Avenue where it still resides. Pioneers of the early office days included Barbara T., the first employee and Jewel H., the second employee. Later Madeline W. and Irene S. were Office Managers. For a long time Pat W. filled the role. Bill F. was the first part-timer who held down the fort during evening hours. Later Gloria H. filled the role as Office manager and Don. F. took over as part-time evenings and the weekends. Tom C. became Office manager around the mid-90's and brought along Keith B. doing part-time service until 2012 when Keith passed away. Our present Office Manager Timothy S. has been managing the Office since September 1999. Part-time

### District 2 - Tampa Bay Area Institutions Committee covering Hillsborough & East Pasco Counties CONTACT---(877) AATAMPA or (877) 228-2672

Mike B. opened the January 8, 2022, TBAIC Zoom meeting with the Declaration of Unity. Attendees: Mike B., Tom F., Rich R., Scott S., Jason C., Tracy B. Chris D., Jenn F., John O., Kara H., and John T. Attendees introduced themselves and their role with the committee. First time attendees included Chris D., Jenn F., John O., and Kara H., who all recently expressed an interest and/or volunteered to chair treatment center meetings. Thanks to all attendees for their service to AA. Mike B. presented the chair report. Mike said he attended the January district meeting where several motions related to the upcoming area meeting were discussed. In addition, an on-line poll was taken regarding the upcoming area meeting. Results tabulated from our district and other districts revealed overwhelming support to have a virtual rather than in-person or hybrid area meeting. Accordingly, the area meeting scheduled to be held in Sarasota on January 14- 16th will now be a virtual meeting held via Zoom. John T. asked if there were any questions or comments regarding the December minutes. Nothing was mentioned. The minutes were approved. Scott S. presented the treasurer's report. Pink Can balance is \$11,407.78. Upcoming expenses include post office box rental of \$188 due in March and the monthly storage fee of \$50 paid to Tri-County Central Office. The only other expected expenses would be for literature. The report was approved. INSTITUTION MEETINGS UPDATES Treatment Center Meetings - John T. said ACTS Amethyst returned to in -person meetings last week. They require visitors to show a valid Covid vaccine card and to wear a mask. They requested we hold two meetings a day seven days a week. We have volunteers to chair all meetings except Saturday and Sunday 7PM and Sunday 1PM. The Monday 1PM is the only Zoom meeting being held. Tampa Community Hospital detox, North Tampa Behavioral and New Beginnings have suspended all meetings due to Covid. ACTS detox, DACCO and other treatment center meetings are still not being held due to Covid. In-person meetings are being held at River Oaks, Salvation Army, Broad Prep Recovery and Brandon Real Recovery Community & Environment. One of the Salvation Army meetings is a hybrid meeting. John O. mentioned that he has been chairing and/or attending meetings at White Sands Treatment Center and also at North Tampa Real Recovery Community & Environment. John T. said he would get details from John O. and add it to the hospitals and institutions meeting list. Jason C. said all is going well with meetings at River Oaks treatment center. He mentioned that the initiative to take some clients to outside meetings may re-start in the near future. Jason C. also mentioned that he heard DACCO had changed its name to Cove Behavioral. John T. said he would check on that and change the meeting listing to reflect the name change, if needed. 

Orient Rd Jail – Rich R. said no meetings were held over the holidays. He said he and Michael P. have been conducting in-person meetings on Sundays at 10:30AM. He said a third person wants to volunteer but can only do so if the meeting time is changed which could happen in the future. Mike B. said he knew of a man who was in the process of completing his application and orientation and he said he would have the individual contact Rich.  $\Box$ Falkenburg Road Men's Jail - Mike B. said Buddy H. told him one in-person meeting a week was being held on Saturday. 

Falkenburg Road Women's Jail - Mike B. read a report from Sara R. which said no meetings were held over the holidays but that three in-person meetings with experienced volunteers are scheduled for this month. She added that one recent meeting had twenty-two attendees and that more volunteers will be needed if more meetings are added. 

Pasco Women's Jail – Tracy B. said still no in-person meetings are being held. 

Zephyrhills CI -Tom F. said in-person meetings are being held and going well. He said inmates enjoyed the privilege of having cookies brought in for the New Year's Eve meeting. He said the weekly meeting has had between 15 and 20 attendees. 🗆 W T Edwards – John T. said Hezekiah D. had some health issues and missed a few weeks but was planning to continue doing the in-person meetings on Thursdays. Bridging the Gap - Mike B. said he

received three calls and provided meeting information to callers. Tracy B. said she received one call and provided information to meetings in South Tampa. She said she also had three separate calls from the same caller who was referred to AA in Hernando County. John T. said he received no calls but Hezekiah D. and Tracy S. both received one call each and provided meeting and/or AA speaker information to the callers. John T. said a few volunteers were added to the contact list and a revised list will be forthcoming. Man on the Bed - Tom F. said he received one call. The individual was provided meeting information and also sources for sober housing. OLD BUSINESS: Mike B. recapped the previous discussion on how to use the Pink Can balance. He said he will mention the issue at next week's area meeting and will bring back any identified needs by other districts at the next TBAIC meeting. NEW BUSINESS: Mike B. said there is always a need for volunteers particularly with the jail meetings. He urged attendees to spread the word. Mike B. discussed the email received from management of True Core Behavioral Solutions regarding the program they will be starting for juvenile females starting in February under contract with the Florida Department of Juvenile Justice. Jason C. had previously expressed interest in the program and said he would be willing to serve as committee coordinator for the program. He said he would contact True Core management to discuss particulars. He said he would contact the Sisters in Sobriety home group for volunteers for meetings due to the proximity of the home group meetings and the True Core location (East Tampa/Brandon). He also welcomed any other female volunteers. The TBAIC literature process was discussed. Scott S. said when literature is in the storage cabinets at central office, individuals carrying meetings into institutions, can obtain literature directly from the cabinets. He said the sign out log should be completed. Scott S. said he had replenished literature in the past but had not done so lately. John T. said there probably is a need to replenish/add things such as the newest meeting schedules, Big Books, 12 and 12 and some pamphlets to the storage cabinets. John said he would be willing to help Scott with that process and they tentatively agreed to do so this coming week. Scott said the committee should review and approve any request for literature not contained in the storage cabinets. Meeting adjourned with the Responsibility Statement and the Lord's Prayer. The next TBAIC meeting will be Saturday, February 12th, at 9:30 AM via Zoom.



☺ Today in January of 2022 COVID has changed the way many groups contribute to the Central Office. Some groups have remained steady in their contributions, some groups have gone to ZOOM, A few ZOOM groups have made some contributions and some groups are Hybrid (in-person & ZOOM), other groups have folded for a lack of a space to have their meeting and some new groups are starting up, and now many groups are getting back to normal pre-pandemic live meetings. Things are looking up and getting better. It's certainly a time to renew our efforts and practice the meaning of the Serenity Prayer a little bit more. We currently have around 210 Groups in the Hillsborough-East Pasco area with around 524 meetings weekly. Contributions in January totaled \$ 10,561.87. This accounts for what 72 Groups or Individuals in our area have contributed in January. Included \$ 46.00 from 1 member for the Birthday Club Our literature sales for January was \$ 8,815.84. This includes sales from A.A. material and non-A,A, material (medallionsetc.) Our total income for January was \$ 19,377.71. Our Total Cost of Goods Sold was \$ 6,847.23. Subtracting the Total Cost of Goods Sold from our January income left us with a Gross Profit of \$ 12,530.48. Our Total Expenses for January were \$ 10,053.87. Subtracting our Expenses from our Gross Profit gave us a Net Income of plus+\$ 2,476.61 for the month of January. I have to express my Gratitude to not only to the A.A. 
