WHAT CAN YOU DO—HOW YOU CAN HELP YOUR CENTRAL OFFICE

As a member of an A.A. group, you can do a number of things to serve your Group, Central Office and Alcoholics Anonymous as a whole.

Encourage your Group to elect a Central Office Rep who can attend the Central Office Council meeting. Become a Central Office Rep. As a C.O.R. you can inform your Group by arranging with the Group Secretary for a few minutes to give an Objective and Unbiased, interesting account of what Central Office is doing so the Group can render an informed "Group Conscience" when asked.

It is suggested that you read the announcements that are of importance to your Group. Know the By-Laws which are a set of guidelines used in the operation of the Central Office. . Keep your Group's record's up-to-date. Be sure your Group information is accurate in the "meeting schedule" and report any changes to Central Office. Help keep A.A. solvent by making sure the Treasurer or the member who handles the "Seventh Tradition" money is informed as to where the money goes after Group expenses are met.

OUR PRIMARY PURPOSE

Tradition 5 states that "Each Alcoholics Anonymous group ought to be a spiritual entity **having but one primary purpose**—that of carrying its message to the alcoholic who still suffers. This is the Central Office's primary role: **"to carry the message."** We do that by providing ways and means for the alcoholic to get to an A.A. meeting and/or A.A. members to get to the alcoholic. Thus comes our Twelfth Step work. In order for us to stay sober and maintain our own sobriety, we <u>must</u> carry the message to others. But how do you, as a Central Office Representative do this most vital function?

- Make sure Central Office has your correct phone number and address. You are now the main and very possibly only contact between Central Office and your Group. A suffering alcoholic's life could depend on this communication. This way, if a Twelfth Step call is requested in your area, the message can be relayed to you and your Group for real on-hands Twelve Step work.
- 2. Just because you are receiving the call does not mean that you are expected to make all of them yourself. Keep an up-to-date list of all Group members and be aware of which ones are available to do Twelfth Step work. The calls should be distributed as evenly as possible so that all who wish to do so have the opportunity to participate.
- 3. It is usually considered good practice to have at least two members make the call, possibly one older and one newer member. At least one woman should be along during calls on female prospects, if at all possible.


(A HELPFUL SUGGESTION ONE DAY AT A TIME)

WE REALIZE WE KNOW ONLY A LITTLE. GOD WILL CONSTANTLY DISCLOSE MORE TO YOU AND TO US. ASK HIM IN YOUR MORNING MEDITATION WHAT YOU CAN DO EACH DAY FOR THE MAN OR WOMAN WHO IS STILL SICK. THE ANSWERS WILL COME, IF YOUR OWN HOUSE IS IN ORDER.

Sobriety definitely can become a habit. Start your morning by asking God (God as you understand Him) to give you a lift for the day; ask for help in your problems, and guidance in Sobriety. At night before going to sleep, thank your Higher Power for the help given you for that day and pray that you may be sober another 24 hours. You'll notice that the folks who are most active have the easiest time keeping sober. Acquire the habit of being faithful to friendships and responsibilities and remember the greatest pleasure in life is to do a good turn in secret and have it discovered by accident.....

In Twelfth Step work (in which most A.A.'s are adept) we have no end of communication: The sponsor talks to the drunk; speakers talk to and at us; we talk to each other. When it comes to general service work the Third Legacy that Bill W. felt so keenly about-the situation is considerably different. We first must get the attention of the alcoholics who are still busy recovering. Then we must get them to focus a bit on the service story, on those newly discovered service responsibilities. We are actually asking them to take time out from the nuts and bolts of recovery to think about another phase of their new lives-this one seemingly very long-range. So communication starts off being difficult until the A.A.'s get service work into perspective-and until they find their way into the Service Manual and into service literature. But they will learn and they will become interested. And you will find that the teaching process is rewardingperhaps not the thrill of your first Twelfth Step success, but a thrill nonetheless. Ask any Delegate.

Mike B. opened the February 12, 2022, TBAIC Zoom meeting with the Declaration of Unity. Attendees: Mike B., Tom F., Rich R., Sara R., Scott S., Jeremy G., Tracy B., Hezekiah D., Rufus S., and John T. New attendee was Rufus S. He expressed an interest to return to institutions service work. Thanks to all attendees for their service to AA. Mike B. presented the chair report. Mike said he attended the January area business meeting and both the treatment and corrections workshops. He said the area corrections committee has been reviewing the corrections workbook and said that anyone interested is welcomed to attend the next meeting which will be on March 7th. Mike also said he mentioned the committee's willingness to donate literature to other districts and he received requests from people in 5 districts. The estimated cost of the requests totaled \$1,750 which may be adjusted due to shipping costs. Mike presented a spreadsheet showing the literature requested and associated costs. He asked if there were any objections to buying and sending the literature. No one objected. Accordingly, the literature will be purchased either at central office or via online sources. Mike said he did not attend the recent district meeting. John T. said he attended the meeting and the motion to fund the bus tail ad was approved after much discussion. John T. asked if there were any questions or comments regarding the January minutes. Nothing was mentioned. The minutes were approved. Scott S. presented the treasurer's report. Pink Can balance is \$12,173.73. Contributions for the month totaled \$952.17. The report was approved. INSTITUTION MEETINGS UPDATES
Treatment Center Meetings – John T. said no major change in treatment center meetings. He said 12 live meetings and 1 Zoom meeting are being held at ACTS Amethyst. The only meeting without a chairperson is Saturday 7PM. The director of ACTS Amethyst asked that due to limited space only 2 outside people attend meetings. Also, all attendees must show a valid Covid vaccine card and wear a mask. DACCO is now called Cove Behavioral Health. No other changes to treatment center meetings. Mike B. read an e-mail he received from ACTS detox saying they needed AA literature and were ready to resume meetings. John T. said he would contact the sender and arrange for both the literature and volunteers to chair meetings. Jeremy G. announced that there is a new meeting geared towards veterans being held at Our Place in Brandon on Thursday at 7PM. He asked that this be mentioned at treatment center meetings.
Orient Rd Jail - Rich R. said he and Michael P. have been conducting in-person meetings on Sundays at 10:30AM. He said a third person wants to volunteer but can only do so if the meeting time is changed which could happen in the future. He added that he was trying to schedule orientation for several new volunteers. \Box Falkenburg Road Men's Jail - Mike B. said Buddy H. told him one in-person meeting a week was being held on Saturday.

Falkenburg Road Women's Jail - Sara R. said Sunday afternoon meetings are being held. She said there are sufficient volunteers for those meetings. She said 16 people attended a recent meeting. She said more volunteers will be needed for Monday meetings to be added.

Pasco Women's Jail –Tracy B. said still no in-person meetings are being held due to Covid spread inside the facility. D Zephyrhills CI - Tom F. said in-person meetings are being held and going well. He said last night was the first meeting since January. Visitors were not allowed in the facility for several weeks due to an outbreak of Covid omicron which has now been controlled. \square W T Edwards – Hezekiah D. said meetings on Thursday night are going well with 6 to 10 attendees. He said this past week there was more participation by attendees. Bridging the Gap - John T. read the report he received from Tracy S. which stated: This month there were 3 calls in ring central which I returned. 2 were Lancaster county clerks and the third I was able to help find meetings. 3 others were referred to us from Pasco county which have release dates in Feb, so I will return those calls this month. No calls via my personal number. Tracy B. said she received one call. She said the individual told her she attended meetings at Falkenburg Road Women's Jail and was released and was interested in attending meetings.

Tracy said she contacted several individuals on the call list but had no success with connecting the individual with anyone. She said she plans to take the individual to a meeting tonight. No one else received any calls. OLD BUSINESS: Mike B. said the Pink Can fund decreased as a result of the requests he received and approval for purchases. He said the requested literature will be purchased and provided to the requesters. NEW BUSINESS: Mike B. said there is always a need for volunteers particularly with the jail meetings. He urged attendees to spread the word. Rich R. said he was approached by a member who carries meetings to the women's jail in Parrish about Grapevine magazines. He asked if there was a way to provide Grapevine magazines for that facility. Mike B. suggested the committee purchase 4 sets of 30 back issues (\$54 per set) of Grapevine magazines for that facility. It was mentioned that the facility is in Manatee county which is covered by District 4. There were no objections to the suggested purchase of 120 back issues of Grapevine magazines. Scott S. said he would make the online purchase and have Grapevines sent to Rich's home address John T. mentioned the stamping of literature purchased by the committee and provided to institutions. In the past, all literature was stamped. John mentioned that the stamp shows the phone number for Bridging the Gap program which he understood was for treatment centers and not for correctional facilities. He asked if the stamping procedure should be changed. Sara R. said a few years ago, she was told by jail officials that any books stamped with black ink would become property of the jail and inmates would only be allowed to keep items if items were stamped in red ink. Sara said she would see if that is still the case. Mike B. said the issue should be tabled until next meeting to see if we should change our process and/or buy a red ink stamp. John T. mentioned the request Scott S. received from the Old School Group for participation in their service workshop in March. The workshop will be held on from 1 to 5PM on Saturday, March 19th at the Old School Group meeting place in Lutz. Mike B. and John T. volunteered to participate. Rufus S. mentioned that he wanted to be involved with meetings. Mike B. suggested that Rufus chair the Saturday 7PM meeting at ACTS Amethyst. Rufus agreed to do so starting next Saturday. Meeting adjourned with the Responsibility Statement and the Lord's Prayer. The next TBAIC meeting will be Saturday, March 12th, at 9:30 AM via Zoom.

4. The members might also be matched up with the prospect as to age or related occupation. Everything helps when trying to establish an area of Fellowship in addition to the common bond of alcoholism. Quite often a new prospect is not entirely convinced of the need for A.A. and anything which assists in overcoming the "you don't understand my problem" attitude can be very helpful. We have found it very helpful for members to read Chapter Seven of the Big Book just prior to making a Twelfth Step call so they are aware of it's suggestions for them. Also keep a current list of public and private institutions which accept alcoholic patients and the entrance requirements in case the prospect needs hospitalization 5. Bring to the meeting tables discussions on Twelfth Step work. How to do it, why we do it, etc. The more discussion on Twelfth Step work, the better everyone will be prepared when it actually happens. And it will happen!!! HANDLING TWELFTH STEP CALLS "Put yourself in the other person's shoes", is a good rule to follow whenever you receive a Twelfth Step call. Remember that only complete and utter despair and desperation drives a "candidate" to that final act of surrender—a call to the A.A. Central Office. It's a cry for help from a sick, frightened human being who has run out of hiding places. How quickly anyone of us responds to this cry could be a matter of life or death. If this sounds over dramatized, it's only to impress on each and everyone of us the urgency of fulfilling our obligation and responsibility in carrying the message of sobriety and hope to the alcoholic who still suffers. The whole purpose (besides keeping us sober) when making a Twelfth Step call, is to acquaint the "candidate" with the program of Alcoholics Anonymous. By your own example and by what you say, you can instill the hope that he or she can learn how to get along without drinking and that we have found a way to stay sober. Because no two people you call on will be in the same state physically, emotionally a	 taking your "prospect" to their first meeting, but if they are sober and eager it might be good to take them sooner. Again, you will have to play it by ear. Remember, it was a big step to make the initial call for help, and now that he has made it, he wants to get going. 6. Mention anonymitythat it is the spiritual foundation of the program, that his name will go no further than within his own Group and the members will respect his anonymity. 7. If the spouse shows interest, one of the two people making the call should talk to them and explain about the closed meetings and also that they are welcome to attend open meetings and/or Al-Anon. Don't force this. 8. It is not a good idea to hand out money. In Chapter 7 the Big Book says, "The men who cry for money and shelter before conquering alcohol, are on the wrong track." Let your good judgment govern. On a 12th Step call we try to "carry the message," which simply means that we try to help a fellow alcoholic on the road to sobriety by showing him or her the waytaking them to meetingskeeping in personal touch. In other words, we lend a helping hand until they are able to stand up for their self. This is a most rewarding expenditure of a little time and effort on our part. 9. Remember, we are not doctors. No matter how well meaning, we should never give any medication				
 SOME SUGGESTED GUIDELINES Tell the person about the program; that it leads to a comfortable, happy way to live without drinking. Tell him or her about the 12 Steps—usually their logic makes a deep impression. In many cases it has been found helpful to explain the physical allergy to alcohol (the phenomenon of craving); that something went "haywire" with his body chemistry and that he can no longer tolerate alcohol because it sets up a chemical reaction within the body that he/she cannot control, and for this reason we have to stay away from that first drink. Take a Big Book along and offer to let them borrow it for a time, but keep in mind that some people learn by listening rather than by reading and don't be disappointed if be doesn't ask to read the book right 	of hurting their self, what kind of mood are they in, are they just looking for someone to talk to with no real intention of wanting to sober up, are they angry and demanding that Alcoholics Anonymous fix them right nowthe list can go on. We can only say that we must try to help them, even if it's only a phone call telling them to call back after their spree. At least someone from A.A. made an attempt. Remember, A.A. is for those who want it. "If you have decided that you want what we have and are willing to go to any length to get it," as our Big Book says.



Enabling Takes Many Forms: Many times when family and friends try to "help" alcoholics, they are actually making it easier for them to continue in the progression of the disease. This baffling phenomenon is called enabling, which takes many forms, all of which have the same effect -- allowing the alcoholic to avoid the consequences of his actions. This in turn allows the alcoholic to continue merrily along his (or her) drinking ways, secure in the knowledge that no matter how much he screws up, somebody will always be there to rescue him from his mistakes. What is the difference between helping and enabling? There are many opinions and viewpoints on this, but here is a simple description: **Helping** is doing something for someone that they are not capable of doing themselves. Enabling is doing for someone things that they could, and should be doing themselves. Simply, enabling creates an atmosphere in which the alcoholic can comfortably continue his unacceptable behavior.





Central Office provides a number of services acting as a clearing house for the convenience of members and groups, provides phone service for twelfth step calls and other inquires, helps with the coordination of group activities and keeps track of meeting times and changes and the printing of the schedules. We also edit and print our monthly newsletter. In addition we sell all Alcoholics Anonymous General Service Conference Approved Literature and some other materials requested by our AA members.
